# SECRETARY'S REPORT - No report.

STUDENT REPRESENTATIVE'S REPORT - Zaire Frison reported the following:

- On November 10th, Student Council sponsor Mrs. Jen Galcik organized a safety presentation for HHS students. Approximately 150 students participated in the Simulator presentation in the back parking lot of the high school. The Safety Simulator is an educational tool that enables students to feel first-hand how alcohol and other adverse conditions impair the ability to safety operate an automobile.

- Congratulations to **Mr. Sam Albert and the Varsity Football Team on an outstanding season!** Thank you, Coach Albert, for instilling in our students the values of commitment, hardwork, teamwork and school pride! Thanks also to **Mr. Matt Beresik, Mr. Lee Lynn and Mrs.Lisa Evans** for their commitment and guidance of the **Marching Band** this season! And to **Mrs. Bonnett** for her leadership and hard work with the **Varsity Cheerleaders!** These young ladies went above and beyond to promote school spirit and school pride! And Finally Thank You to **Mr. Chuck Debor** and **Mr. Jay Morgan** for their tireless efforts in making sure all of our fall events ran smoothly.

- Congratulations, also, to **Mr. Abbott** and his students on a successful and fun **Fall Play**, *Murder Most Fowl*, which debuted on November 8<sup>th</sup> and 9<sup>th</sup>.

- On Wednesday,November 12th, the guidance counselors met with the senior class during Mentoring time where they shared with them the resources on the Guidance page of the district website including links to available scholarships, college majors information, bureau of labor statistics, college board and other financial aid seminars. Each student also received a packet of information to help them begin planning for college and careers.

- Last week, the Social Studies Department hosted the 13th Annual Veterans Day Living History Program. We invite the veterans to come and share their stories with our students. Special thank you to Paul Minarik, who served on a Navy Destroyer during World War II, Dave Christopher, who served with the US Army in Vietnam; Bill Miller, who served in the US Army in Vietnam; Frank Maier, drafted for Vietnam but served with the US Army at Checkpoint Charlie on the Berlin Wall; Gary Lilly, who served in the US Navy in Vietnam, Vincent Krzeminski who was drafted for Vietnam and served with the US Army as an MP with the Executive Fight Detachment- guarding President Johnson's Helicopters and Karen Hassler who is currently a Captain in the US Army who served in both Iraq and Afghanistan. Krzeminski, organizer of the event, says "Each day when we come to school, as administrators, teachers, staff and students; we get to do so in a free democratic society because of the sacrifice and efforts of these presenters and the millions of other veterans that served us, many at a high cost and sacrifice, and made us free."

The members of the National Honor Society have chosen the Make-A-Wish foundation as their charitable benefactor this year. A few weeks ago Ms. Andrea Ballas met with the entire NHS and explained how the foundation works and showed them a moving video of a boy getting his wish. # SUPERINTENDENT'S REPORT – Dr. Michael Bjalobok reported the following:

- I have requested our solicitor, Ira Weiss, to contact attorney Philip DiLucente and request that he cease and desist in making disparaging remarks about the Highlands School District. Mr. DiLucente's misquotes about Highland's policy toward bullying are irresponsible. His allegations regarding the District's commitments are unfounded. This weekend Mr. DiLucente went to the media and stated he was disappointed in not hearing from the District, when, in fact, he did not call the District. We haven't heard from Mr. DiLucente regarding the soccer field incident in over a month. Highlands is focused on addressing the needs of the students and families who are served by this district, and not on continuing to

replay past events to serve other purposes. The students involved are back at school, the victim and his family have communicated to me that they are satisfied with the way the District addressed this incident, and the Highlands community is moving forward in a positive educational climate, free from bullying and hazing. The Highlands School District requests that everyone attempt to move forward in a positive and productive manner. The School District deserves an apology from Mr. DiLucente.

- The recently released School Performance Profiles (SPP) for Highlands schools were a dismal representation of the district. The district administration were notified of a review period and given a link to access the site prior to its release. However, the link was not operational and did not allow the district to offer revisions or corrections to the state's calculations. The district was not able to verify or correct errors. According to the district calculations by the building principals, SPP scores should be as many as 10 points higher for some of the district's schools. Regardless of this, we do have an improvement plan in place for the district. I have been here for one and a half years, and began that process the moment I returned to the district. First, we analyzed the issues that needed to be addressed and put various programs in place to better identify areas that need improvement. At the high school, we are working with the Model Schools Assessment. At the middle school, we are working with eh PA Middle Schools Association to focus on what a true middle school concept is and how we can model that. At the elementary levels we have the students and staff learning on the Compass Learning system, which ties in to the NWEA MAP testing and data analysis. This will be the true growth model for our students – not the PSSA. Next week, administration will be participating in a webinar to learn the back end of NWEA and how to compare and analyze the student data and results. This process is just that – a *process* – not a magic bullet, but a very comprehensive and all-encompassing plan with various elements that all fit together. It is a process still in its infancy. The SPP scores are a very dismal representation of our district, but we will improve, we will keep moving with professional development and identification of areas of need. We are committed to providing the best opportunities.

# **ASSISTANT TO THE SUPERINTENDENT'S REPORT – Mr. Patrick Graczyk** reported the following:

- An HVA Committee has been set up to explore options for improving the program. A limited Google+ site has been set up for committee members to continually exchange ideas and thoughts about the program. The next meeting is tomorrow.

- A two-day professional development was held in October for teachers to learn about Student Learning Outcomes. The SLO is a part of the Educator Effectiveness Model and is comprised of a goal statement, a big idea and relevant assessment to show how the students are performing.

- The Bright Bytes Survey is completed. We are now analyzing data and the feedback is voluminous and of great variety! We will report back about this at a later board meeting. \*Dr. Bjalobok added on to Mr. Graczyk's report that a Questeq survey also has been completed and is being analyzed.
