## Annual Reorganization Meeting

### December 6, 2010 School Board Meeting

**ROLL CALL** – Seven board members present. **Mrs. Karen Wantland** present by phone. **Mr. William Heasley** absent.

#### **APPOINTMENT OF TEMPORARY CHAIRPERSON**

On notion by Mrs. Fox and seconded by Mr. Lang to appoint Mrs. Thimons as temporary chairperson. Roll call, all ayes. Motion carried.

#### **ELECTION OF PRESIDENT**

Mrs. Thimons asked for Board President Nominations. Mrs. Fox nominated Mrs. Beale and Mrs. Wisner asked the solicitor if she could nominate someone who was not present the solicitor stated no because that person could not publicly accept the nomination. A motion to close the nomination was made by Mrs. Wisner and seconded by Mrs. Beale. The Board appointed **Mrs. Debbie Beale** as **School Board President** with a vote of 6-2.

#### **ELECTION OF VICE PRESEIDENT**

#### **APPOINTMENT OF PSBA LIAISON**

Mrs. Beale asked for the nominations for the PSBA Liaison. Mrs. Thimons nominated Mr. Krzton and Mr. Krzton nominated Mrs. Wisner. A motion to close the nomination was made by Mr. Lang and seconded by Mrs. Fox. The Board voted Mr. William Krzton (six) and Mrs. Wisner (two). **Mr. William Krzton** was elected as **PSBA Liaison** with a vote of 6-2.

#### **ELECTION OF FORBES ROAD CTCT REPRESENTATIVE AND ALTERNATE**

A motion to close the nomination was made by Mrs. Thimons and seconded by Mr. Lang. The Board unanimously voted **Mrs. Carrie Fox** as **representative** and **Mrs. Debbie Beale** as **alternate**. Roll call, all ayes. Motion carried.
