

# Highlands School Board Meeting Highlights July 14, 2008 Special School Board Meeting

# BUILDINGS & GROUNDS - Mr. Misejka, Mr. Heasley

The Board approved requests for use of facilities, as submitted. (Cleared by Administration and as per Board Policy.)

The board rejected the following bid and authorized the administration to re-bid the pool pac unit again, as it is essential to completing repair work on the High School swimming pool:
