APPROVAL OF MINUTES

The Board approved the minutes of the February 18, 2008 Regular School Board Meeting, as submitted.

SUPERINTENDENT'S REPORT

Dr. Karol Galcik announced that senior **Sarah Rowan** has advanced to the PMEA allstate band festival. This is the 3rd consecutive year that Sarah has made it to the states, and she now has the opportunity to audition for the position of top individual trumpet player in the state.

Highlands students attending Forbes Road CTC recently competed in the PTI Visions & Voices High School Competition. **Jim Lettau** won 1st Place for multi-media / web and **Rachel Klaes** received the 3rd Place award.

Jim Lettau and **Brittney Wetmore** were recently inducted into the National Technical Honor Society.

The Board adopted the 2008-2009 School Calendar, as submitted.

The Board adopted the following textbook for the 2008-09 school year:

The Board approved expanding the Heights Elementary Big Brothers & Big Sisters program to include Grandview Elementary. (No cost to District)

The Board approved the Smile Pennsylvania Mobile Dentists Program to be piloted at Grandview Elementary this spring, as submitted. All personnel who will have contact with students will have appropriate clearances.

The Board approved the Job Shadowing / Vocational Experience, as submitted.

The Board approved the Choking Game / Asphyxia Play Survey for Middle School students, as submitted, and with parent/guardian permission.

The Board approved requests for use of facilities, as submitted.

The Board rejected the Grandview door bids.

The Board approved the purchase of 144 Oxford-type shirts for Buildings & Grounds Department personnel from B&J Sporting Goods (lowest quote received) at a cost of \$2,520, for 2008-09 school year and as recommended by the Buildings & Grounds review.

The Board agreed to sell the 2nd Ward Elementary Building to the following highest bidder, in accordance with bid specifications, and authorized Administration and Solicitor to transfer property to said bidder: **Michael and Beth Rabkin** – Amount - \$101,501.10

The Board approved **William Beale** and **Jeff Calarie** as volunteer facility advisors to the Administration, effective upon receipt of Act 34 and Act 151 Clearances and FBI Record Check, and their passing the District's pre-employment drug test.

The Board approved Facility Planning Meeting decisions informing N. The Board approved the proposed 2008-2009 Allegheny Intermediate Unit Program of Services Budget, as submitted. The budget totals \$3,782,025 and reflects a 4.4% increase in the total district allocation.

The Board approved **Roxanne Eichler** as a candidate to the Allegheny County Schools Health Insurance Consortium Board of Trustees.
