A. Specifications

A copy of the official report of <u>butter fat</u>, <u>coliform count</u>, and <u>bacteria count</u> for the month of February 2024, is to be submitted with the bid quotation.

Each item <u>must</u> have a <u>food analysis label</u> which includes total calories per serving as well as carbohydrate, protein, fat, saturated fat, and cholesterol content.

All daily delivery sheets must be properly signed by the receiver of the goods.
