May 11, 2009 Regular School Board Meeting

APPROVAL OF MINUTES - The Board unanimously approved the minutes of the special board meeting held on April 8, 2009 and the regular board meeting held on April 20, 2009.

<u>SECRETARY CORRESPONDENCE</u> – Board secretary Mr. Jon Rupert reported that Siemens submitted an Act 77 report signifying a savings of more than \$821,000 in energy efficiency since 2000.

These students received the award out of 161 students that represented 16 public and private schools. Highlands had 17 students awarded; two of these students, **Colleen Friel** and **Matthew Basista**, received special medals and were recognized in the top ten of the total honorees.

Dr. Baldassare also recognized the following staff members for their achievements:

- Mrs. Wendy Hutchinson, Middle School Science Teacher, was awarded a PPG Grant for \$911 for a proposal she submitted for educational supplements to her curriculum.
- Mrs. Sharon Conway, Food Services Director received notice that Highlands earned the District of Excellence in School Nutrition Distinction from the National School Nutrition Association. There were only 8 winners of this award and Highlands was the only School District in Pennsylvania that won. The District is also under consideration for the 2009 District of the Year Award which includes a prize of a grant of up to \$25,000.
- Mrs. Conway also received the Pennsylvania School Food Service Director of the year award from the School Nutrition Association of Pennsylvania (SNAP).
- The Boosters and Parent Organizations meeting held on Tuesday, May 5 at the Community Center opened communications amongst the different groups and between these dedicated parent volunteers and the Administration.

The group included myself, Athletic Director **Mr. Matt Bonislawski**, Public Relations Manager **Ms. Misty Chybrzynski** and 20 volunteers representing 15 support groups for our young athletes, musicians and elementary students.

The group discussed board policy regarding volunteers, PTOs and Boosters and common problematic situations each faces. We achieved agreement on four specific subjects:

- Clarification of who needs clearances and how long clearances are effective
- Assessments cannot be forced upon parents who are unable or unwilling to pay. Children will not be denied participation because of this.
- Tag days will follow a pre-set district-wide schedule in order to avoid overlapping or excessive soliciting from the community.
- All Booster Organizations will submit by laws, budgets, fundraisers, and officers to the Superintendent prior to the next school year.
