May 17, 2010 School Board Meeting

<u>ROLL CALL</u> – All members present.

The Board unanimously approved the following items:

<u>APPROVAL OF MINUTES</u> – The Board approved the minutes of the April 19, 2010 Regular Meeting, with one correction noted by Mrs. Judy Wisner.

SECRETARY'S REPORT – Mr. Jon Rupert, Board Secretary, reported that the district Safety Committee received certification from the state Department of Labor and will receive a 5 percent discount for workmen's compensation coverage.
